 The prohibitions will not apply in respect of:

 (a) any vehicle being used for the purposes of that event or for fire brigade, ambulance or police purposes;
 (b) anything done with the permission or at the direction of a police constable in uniform or a person authorised by the Council of the London Borough of Southwark.

(TEMPORARY PROHIBITION OF TRAFFIC

- The Council of the London Borough of Southwark hereby gives notice that to enable various works to be carried out, it intends, to make, an order, the effect of which will be to prohibit vehicular traffic from entering part of the above named roads.
- Whilst the works are in progress, or whilst the authorised traffic signs/road markings are displayed, no person shall cause any vehicle to enter, proceed, stop, wait, load or unload at any time in:
 - (a) Dunstans Road, at its junction of Underhill Road and the side of No's 219 Underhill
 - Road

 (b) East Street, between Walworth Place and No's 28 East Street
 - Sydenham Hill, suspend south bound cycle and bus lane between Bluebell Close and Wyvel Place
 Copperfield Street, between Great Suffolk Street and Risborough Street.

Union Street Pepper Street. (2e) as indicated by the signs displayed 3.
- Exemptions will be provided in the Order to permit reasonable access to premises, so far as it is practical without interference with the execution of the said works
- The restrictions will not apply to any vehicle being used in connection with the said works, or for fire brigade, ambulance or police purposes or anything done with the permission or at the direction of a police constable in uniform. 5.
- The works will be in operation for (2a) 11th 22nd December (2b) 11th December 2023, with back up dates of the 22nd January 2024 (2c) 11th 15th December (2d) 11th 22nd December (2e) 9th 10th & 16th 17th December 6.
