PROPOSED INTRODUCTION OF TUI SE HILL WEST CONTROLLED PARKING ZONE (ZONE F) AND AMENDMENT TO ZONE H AND ZONE J

NOTE: This Notice is about proposals to implement the Tulse Hill West CPZ (Zone J) including introducing waiting restrictions, shared use parking places, electric vehicle charging bays and disabled parking bays and including certain Roads in Zones F, H and J. Objections or other comments may be made - see paragraph 6.1

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth, proposes to make The Lambeth (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. **) Order 202* and The Lambeth (Charged-For Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. **) Order 202* and The Lambeth (Charged-For Parking Places, Loading Places) Places) (Amendment No. **) Order 202* under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The general effect of the Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions Order 2023 so as to:
 (a) revoke restrictions on waiting in Leigham Vale adiacent the rear of No. 136 Palace Road, between the hours of 8.30a.m. and 6:30a.m. Monday to Friday:

 - revoke the e-scooter parking place in Palace Road, opposite Dykes Court:
 - revoke the Electric Vehicle charging place in Lanercost Road, outside No. 2;

 - impose At Any Time Waiting Restrictions in certain lengths of the streets specified in Schedule 1 to this Notice; impose restrictions on waiting in certain lengths of the streets specified in Schedule 2 to this Notice between the hours of 10:00a.m. and 4:00p.m. Monday to Friday;
 - impose restrictions on waiting in certain lengths of High Trees between the hours of 8:30a.m. and 6:30p.m. Monday to Friday;
 - designate an e-scooter parking place in Palace Road, opposite Dykes Court;
 - designate permit electric vehicle charging places in certain lengths of the streets specified in Schedule 3 to this Notice;
- designate existing electric vehicle charging places to permit holder electric vehicle charging places in certain lengths of the streets specified in Schedule 4 to this Notice
- 3. The general effect of the Charged-For Parking Places Order would be further to amend the Lambeth (Charged-For Parking Places) Order 2023 so as to:
 - designate Zone F shared use resident permit holder or paid for parking places that will operate between the hours of 12:00p.m. to 2:00p.m. Monday to Friday inclusive, excluding bank holidays, in certain lengths of Palace Road;
 - designate Zone F shared use permit holder or paid for parking places that will operate between the hours of 12:00p.m. to 2:00p.m. Monday to Friday inclusive, excluding bank holidays, in certain lengths of Palace Road; designate Zone H shared use resident permit holder or paid for parking places that will operate between the hours of 8:30a.m. to 6:30p.m. Monday to Friday inclusive, excluding bank holidays, in certain lengths of High Trees; designate Zone H shared use permit holder or paid for parking places that will operate between the hours of 8:30p.m. Monday to Friday inclusive, excluding bank holidays, in certain lengths of High Trees; designate for the parking places that will operate between the hours of 8:30p.m. Monday to Friday inclusive, excluding bank holidays, in certain lengths of High Trees;

 - designate Zone J shared use resident permit holder or paid for parking places that will operate between the hours of 10:00a.m. to 4:00p.m. Monday to Friday inclusive, excluding bank holidays, in the lengths of roads specified in Schedule 9 to this Notice;
 - designate Zone J shared use permit holder or paid for parking places that will operate between the hours of 10:00a.m. to 4:00p.m. Monday to Friday inclusive, excluding bank holidays, in the lengths of roads specified in Schedule 9 to this Notice;
 - specify that:
 - each parking place may be used, subject to the provisions of the Order, for the leaving during the permitted hours of such vehicles as are passenger vehicles, goods carrying vehicles motorcycles or invalid carriages displaying a valid parking ticket or permit; the annual charge for permits for the parking places specified in 3(a), 3(b), 3(c), 3(d), 3(e) and 3(f) above and Schedule 4 and Schedule 5 would be as specified in Schedule 6 to this Notice; the charge for pay to park parking in the parking places specified in 3(a), 3(b), 3(c), 3(d), 3(e) and 3(f) above would be as specified in Schedule 7 to this Notice;

 - any resident whose usual place of abode is specified in Schedule 8 to this Notice may apply to the Council for the issue of a resident visitors vouchers valid for use in the permit parking places in Controlled Parking Zone F; any person who occupies premises in any street specified in Schedule 8 to this Notice may apply to the Council for the issue of a business permit valid for use in the business permit parking places specified in in Controlled Parking Zone F; any resident whose usual place of abode is specified in Schedule 9 to this Notice may apply to the Council for the issue of a resident visitors vouchers valid for use in the permit parking places in Controlled Parking Zone F;

 - any person who occupies premises in any street specified in Schedule 9 to this Notice may apply to the Council for the issue of a business permit valid for use in the business permit parking places specified in in Controlled Parking Zone H;
 - any resident whose usual place of abode is specified in Schedule 10 to this Notice may apply to the Council for the issue of a residents permit or resident visitors vouchers valid for use in the permit parking places in Controlled Parking Zone J;
 - any person who occupies premises in any street specified in Schedule 10 to this Notice may apply to the Council for the issue of a business permit valid for use in the business permit parking places specified in Controlled Parking Zone J.

Objections and representations may also be made for an additional 21 days to allow for additional consultation over the summer period. Any objection may be communicated to, or be seen by, other persons who may have an interest in this matter.
