

# **LONDON BOROUGH OF SOUTHWARK**

## **ROAD TRAFFIC REGULATION ACT 1984 SECTION 14(1)**

### **(CROXTED ROAD, PENARTH STREET, SHAD THAMES, SUNRAY AVENUE, ASYLUM ROAD)**

#### **(TEMPORARY PROHIBITION OF TRAFFIC/WAITING & LOADING RESTRICTIONS)**

1. The Council of the London Borough of Southwark hereby gives notice that to enable various works to be carried out, it intends, to make an order, the effect of which will be to prohibit vehicular traffic from entering part of the above named roads.
2. Whilst the works are in progress, or whilst the authorised traffic signs/road markings are displayed, no person shall cause any vehicle to enter, proceed, stop, wait, load or unload at any time in:  
  
(2a) Croxted Road, south bound lane of carriageway, between Thurlow Park Road and No's 6.  
(2b) Penarth Street, between Ilderton Road and The Pen Theatre.  
(2c) Shad Thames, between Queen Elizabeth Street and Butlers and Colonial Wharf.  
(2d) Sunray Avenue, between No's 27 and it's blocked end.  
(2e) Asylum Road, 'at any-time' waiting & loading restrictions will be introduced, between No's 68 and No's 98 on both sides of the carriageway.
3. The alternative routes for affected traffic will be (2a) Thurlow Park Road, Allen Park, Park Hall Road. (2b) Record Street, Ormside Street, Manor Grove Ilderton Road (2c) Queen Elizabeth Street, Curlew Street, Gainsford Street. (2d) Crosswaite Avenue, Dylways, Blanchdowne, Denmark Hill, Sunray Avenue, Nairne Grove, Woodfarrs. (2e) not applicable
4. Exemptions will be provided in the Order to permit reasonable access to premises, so far as it is practical without interference with the execution of the said works.
5. The restrictions will not apply to any vehicle being used in connection with the said works, or for fire brigade, ambulance or police purposes or anything done with the permission or at the direction of a police constable in uniform.
6. The closure will be in operation on the following dates (2a) 11th – 15th August (2b) 8th August – 26th September (2c) 11th – 14th August (2d) 8th – 9th August (2e) 4th – 6th August
