THE A201 GLA ROAD (BLACKFRIARS ROAD, LONDON BOROUGH OF SOUTHWARK) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2025

- 2. The purpose of the Order is to enable crane operational works to take place at A201 Blackfriars Road in the London Borough of Southwark.
- 3. The effect of the Order will be to prohibit any:
