

## ROAD TRAFFIC REGULATION ACT 1984

### THE A200 GLA ROAD (BERMONDSEY STREET, LONDON BOROUGH OF SOUTHWARK) (TEMPORARY PROHIBITION OF TRAFFIC AND STOPPING) ORDER 2025

1. Transport for London in consultation with the London Borough of Southwark hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
2. The purpose of the Order is to enable highway resurfacing works to take place at A200 Bermondsey Street.
3. The effect of the Order will be to prohibit any:
  - (1) vehicle from entering, proceeding or stopping on Bermondsey Street between its junctions with Long Lane/Abbey Street and Magdalen Street, local access will be maintained to its junction with White's Grounds;
  - (2) vehicle from proceeding on the A200 Druid Street, Crucifix Lane, and St Thomas Street between its junctions with Tower Bridge Road and Snowfields. Local access will be maintained between Tower Bridge Road and Shand Street. Access to Guy's Hospital will be maintained;
  - (3) pedestrian from proceeding on Bermondsey Street between its junctions with Crucifix Lane and Magdalen Street;
  - (4) vehicle from turning right from Shand Street and Barnham Street into Crucifix Lane;
  - (5) vehicle from turning left from The Tanneries onto Crucifix Lane.

The Order will also allow two-way working on:

- (6) Druid Street and Crucifix Lane between its junctions with Tower Bridge Road and Shand Street;
- (7) Bermondsey Street between the Shiva Building and its junction with White's Ground;
- (8) Weston Street between its junctions with Snowfields and St Thomas Street;
- (9) Snowfields between its junctions with Weston Street and St Thomas Street;

The Order will be effective at certain times between 22nd September 2025 and 22nd March 2026 every night from 8.00 PM until 6.00 AM or when the works have been completed whichever is the sooner. The prohibition will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

4. The prohibitions will not apply in respect of:
  - (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
  - (2) anything done with the permission or at the direction of a police constable in uniform or a person authorised by Transport for London.
5. At such times as the prohibitions are in force alternative routes will be indicated by traffic signs for traffic traveling northbound via Tower Bridge Road, Tower Bridge, Tower Hill Approach, Tower Hill, Byward Street, Lower Thames Street, Upper Thames Street, Queen Street Place, Southwark Bridge Road, Southwark Street, Borough High Street, Duke Street Hill and Tooley Street to normal route of travel. for vehicles over 7.5 tonnes m.g.w travelling in a northbound direction via Tower Bridge Road, Queen Elizabeth Street, Tooley Street, Tower Bridge Road, Bricklayers Roundabout, Great Dover Street, Borough High Street, Duke Street Hill and Tooley Street or reverse to normal route of travel. For vehicles travelling southbound direction via Tower Bridge Road, Bricklayers Roundabout, Great Dover Street, Borough High Street, Duke Street Hill and Tooley Street to normal route of travel. for local access from Crucifix Lane via Barnham Street, Tooley Street, Duke Street Hill and Borough High Street to normal route of travel. for local access from Bermondsey Street via Leathermarket Street, Weston Street, Snowfields, Kipling Street, Long Lane and Borough High Street to normal route of travel. for pedal cycles via Crucifix Lane, Shand Street and Magdalen Street or reverse to normal route of travel. for pedestrians via Crucifix Lane, Shand Street and Holyrood Street to normal route of travel.
