**The Lewisham (Prescribed Routes) (No.6) Order 202\*  
Garthorne Road, SE23**

1. The Council of the London Borough of Lewisham propose to make the above mentioned Order under Section 6 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 "the Act" (as amended), the effect of which will be to: - (a) prohibit motor vehicles from entering or proceeding in that length of Garthorne Road, SE23 at its junction with Grierson Road southwards to a point 3m south of the party wall of Nos.6 and 8; (b) revoke "The Lewisham (Prescribed Route) (No. 6) Traffic Order 1988 which imposes a prohibition of motor vehicles in Garthorne Road above, in its entirety.

2. Exemptions apply (a) for pedal cycles; (b) to anything done with the permission or at the direction of a police constable in uniform; (c) to any person who causes any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or 67 of the Act.

Works may be phased as such that not all restrictions may apply at any one time.

3. The road which would be affected by the Order are A20 Sidcup By-pass and A20 Sidcup Road.

4. The prohibitions referred to in article 2 above would not apply to:

(a) any vehicle being used for police, fire brigade or ambulance purposes or any pedestrian engaged in such purposes; or

(b) anything done with the permission of or at the direction of a police constable in uniform or a person authorised by Transport for London;

(c) any vehicle or pedestrian engaged in works for the cleansing, maintenance, repair, improvement or reconstruction of the roads;

(d) any vehicle engaged in the removal of any obstruction to traffic in the roads.


